### 4. Scope of Indicative Business Offer

This Indicative Business Offer is prepared as a response to the Market Consultation No. 45507 "Determination of the RPV Material Properties of Kozloduy NPP Unit 5 and 6 by Testing of Irradiated Surveillance Samples", issued by NPP Kozloduy, Bulgaria and brought to attention of UJV Řež, a.s., Czech Republic.

The total price of this Indicative Business Offer covers all the activities, specified in the Market\_Consultation\_technical\_part,\_including\_Transport\_of\_the\_Samples, Testing\_of\_Irradiated Surveillance Samples, Modelling of Neutron Fluxes, Determination of Phosphorus Grain Boundary Segregation, Design and Construction of New Boxes with Flat Containers.

Due to unavailability of technical details and limited time horizon, this quote is prepared as Indicative Business Offer for information only. It is not an offer in the sense of Act No. 89/2012 Coll., The New Civil Code, and its acceptance does not create an obligatory relationship between ÚJV Řež, a. s. and the other party, nor a right to conclude a contract.

The total indicative price is 2.309.000,-€.

The works performed within this Indicative Business Offer expect to use the Shielding Transport Container owned by Kozloduy NPP for transport of irradiated samples. Immediately after the samples are received in hot cells of UJV Řež, the Shielding Transport Container is returned to Kozloduy NPP. Prior to return of the tested samples and newly designed boxes with flat containers to Kozloduy NPP, the Shielding Container is transported to ÚJV Řež.

It is important to note that some of the activities of this Indicative Business Offer are onetime-only (model for distribution of RPV neutron flux, design of the box with flat containers). In case of repeated contract, these activities would not be performed, and the total price of the contract would be lower.
